INCITING INCIDENT Jennifer, a married freelance photographer, has packed up her family's life in Sydney and is flying to Cairns Airport in Far North Queensland with young sons Jack & Jasper to begin a new life at Emerald Beach on the edge of the Daintree Rainforest. Her husband, Jonathon, has a new job as Acting GM with Mossman Council. On the plane, Jen is exhausted after spending the past month on her own packing up their lives. She has mixed feelings about leaving Sydney and reminisces about her old family house and the good times there, but is also excited to be making a fresh start. Hanging question – why has the family decided to move so far from Sydney?

GOOD AGAIN Jon throws a party for Jen's birthday. He hires a babysitter and invites colleagues, neighbours and Blythe, as a surprise for Jen. The party is a hit with everyone excited about Carnivale. Jen & Blythe's friendship's rekindled, Narelle is helpful, Stretch is political & doesn't see eve to eve with Jon. We meet Mayor Liz, who has big plans for Jon's job. Jon gifts Jen a 4WD for her birthday. After everyone leaves, Jon and Jen make love but then argue after Jon lets slip he doesn't intend the family remain in FNQ long-term but that they'll return to Sydney.

Jen is shocked to find a letter from Scott in her PO Box. He asks her to tell him what happened the night of the accident & during Lisa's last minutes alive. BAD AGAIN

Jen calls the detective

Jen discovers a large

quantity of cocaine hidden in the house. She confronts Jon about using again. They fight. She runs to the beach with the cocaine and throws it in the ocean. Jon tries to stop her. Janelle & Stretch find them rolling in the water. fighting. Janelle goes into early labour. Douglas Shire Council loses its fight to stop the forced merger from going ahead. Mayor Liz makes moves to sack Jon. Scott tells Jen he's begun therapy with a hypnotherapist to try to regain his memory of the night of the accident. Jen feels torn and terrified of Scott regaining his memory and finding out the truth about what happened the night of the accident.

Narelle tells Jen Jasper is drawing violent pictures at school. Jen confesses family involved in a car accident. Jon won't agree to Jasper getting counselling & refuses to discuss accident. DENOUEMENT (TIE ALL LOSE ENDS TOGETHER)

Jon is charged with the manslaughter of Lisa and baby Ben. He is also charged with Jen's attempted murder and cocaine possession. Key evidence of Jon's guilt is found on Jen's mobile phone, which she'd used to record her last conversation with Jon about the accident, during which he openly discussed the truth about the accident. Or does Scott find his phone amongst his possessions and Lisa had been recording their trip to hospital when the car accident happened. Scott found the phone, had it repaired and found the video, which he now submits to the court as evidence of Jon's cover-up.

EXPOSITION (BACK STORY - REVEAL DIFF THINGS AT DIFF TIMES THROUGH RISING ACTION)

12 months earlier. Jonathon coerces his wife Jennifer to take the blame for a fatal car accident he causes on a road near their family home in Sydney which kills a heavily pregnant woman, Lisa and leaves her husband, Scott, in a coma. Jen escapes manslaughter charges but is deeply traumatised by the accident. She persuades Jon to move as far as possible from Sydney.
